In this role, you will be part of the team responsible for the daily operational processes related to Coordinated Security Analysis (CSA), including shift-based activities that ensure the continuous and reliable operation of our services.

Beyond your shift duties, your main focus will be to support and contribute to regional security analysis and related pan-European activities, in which SEleNe CC is involved.

You will work closely with engineers, TSOs and other RCC colleagues to monitor and analyze security assessment results, investigate and resolve data quality issues, and support the smooth execution of operational processes. While the role involves power systems and data, it is equally about stakeholder interactions, coordination and ensuring effective and timely communication.

If you enjoy combining technical challenges with operational responsibility and want to be at the heart of European power system coordination, this role could be the right opportunity for you.

Key responsibilities

- Develop a strong understanding of the regulations, methodologies and processes related to regional and cross-regional security analysis.

- Perform power flow investigations related to security analysis using both in-house tools and commercial software.
- Maintain regular communication with TSOs and support the identification and resolution of operational issues related to security analysis activities.

- Participate in operational shifts (carried out 365 days, morning/evening) as part of the role.

- Bachelor's degree in Electrical Engineering, Applied Physics, or relevant;
- At least 3 years of professional experience;
- Strong communication skills, with the ability to identify and disseminate relevant information to the appropriate stakeholders in a timely manner;
- Ability to work effectively in technically complex environments involving power system analysis and security assessment with strong analytical skills;
- Experience working with TSOs, DSOs, RCCs or energy utilities is a strong asset;
- Good organizational and coordination skills;
